**AGREED ORDER ON UNOPPOSED MOTION FOR APPROVAL OF COLLECTIVE

THIS MATTER came before the Court upon Plaintiff's Unopposed Motion for Approval of Collective Action Settlement and To Dismiss Action with Prejudice. Having reviewed the Motion, the Parties' settlement papers and the amounts to be paid to Plaintiff, Settlement Collective Members, and for Plaintiff's attorneys' fees and costs, and the Court being otherwise fully advised in the premises, it is

ORDERED AND ADJUDGED as follows:


1. Plaintiff's Motion is GRANTED. The Court finds that the Parties' Settlement in this FLSA action is a fair and reasonable resolution of a *bona fide* dispute.
2. The Parties' settlement is APPROVED. The Settlement Administrator is authorized to send the notice and issues the payments pursuant to the terms of the Settlement.
3. This Action is DISMISSED WITH PREJUDICE.
4. Without affecting the finality of this Order in any way, this Court will RETAIN JURISDICTION over the Parties to this action for the purpose of the administration

and enforcement of the Settlement until the conclusion of the settlement administration process.

5. The case is closed and all pending motions are denied as moot.
